### Suncor Energy declares dividend

**Calgary, Alberta (February 21, 2024)** – Suncor Energy's (TSX: SU) (NYSE: SU) Board of Directors has approved a quarterly dividend of \$0.545 per share on its common shares, payable March 25, 2024 to shareholders of record at the close of business on March 4, 2024.
